PRODUCT BENEFITS:

- Highly Effective, Multi-Purpose Formulation Combines an Absorptive Clay to "Pull" Deep-Set, Below Surface Stains and a Fine Abrasive Powder to "Scrub Away" Surface Stains.
- Non-Toxic. Non-Flammable. VOC Compliant. Biodegradable.
- Contains Baking Soda to Help Eliminate Odors.

USES:

- Tile, Stone, Concrete, Masonry and Grout Surfaces.
- Can be Added to Most Cleaners to "Boost" their Effectiveness.
- Interior and Exterior applications.

DIRECTIONS:

Read entire label before using. Use only as directed.

APPLICATION STEPS:

Deep Set Stains

- Mix Poultice Stain Remover with water to form a thick paste.
 Expert Tip: Depending on type of stain, can use an OMNI Cleaner or Remover in place of water for enhanced performance (see OMNI Product Recommendation Guide).
- Apply Poultice Stain Remover paste approximately ¼" thick to stained surface. Allow paste to extend beyond the edges of the stain by at least 1".
- 3. Cover paste with plastic and tape edges of plastic to surface with painter's-type tape.
- 4. Allow paste to dwell on surface for 24 to 48 hours.
- 5. Remove the plastic covering the paste.
- 6. Remove paste with a non-marring tool (plastic putty knife).
- 7. After stain has been removed, clean paste with a SpongaUSA™ Sponge, or a white, cotton or micro-fiber towel and water.
- 8. Thoroughly rinse surface with water & dry with a white cotton or micro-fiber towel. A wet/dry vacuum may also be used.
- 9. Some stains may require 2 or more applications.
- If surface is to be sealed, allow 24 hours drying time prior to applying a high quality OMNI sealer (see OMNI Product Recommendation Guide).

Surface Stains

- 1. Apply a small amount of water to surface to be cleaned.
- Liberally sprinkle Poultice Stain Remover to the wet surface and mix into thin slurry.
 - <u>Expert Tip:</u> For stains on vertical surfaces, mix **Poultice Stain Remover** with water into slurry in a container, then applied to the wet surface.
- Scrub surface with a Primo Tools™ White Nylon Scrub Pad or other comparable non-marring scrubbing tool until stain is removed.
 Expert Tip: For large stain surfaces, a low RPM (300-750 RPM) buffer can be used with a white nylon pad to remove stains. Keep surface wet during buffing process.
- After stain has been removed, clean solution from surface with a SpongaUSA™ sponge, or a white cotton or micro-fiber towels and water. A wet/dry vacuum may also be used.
- Thoroughly rinse surface with clean water and dry with a white cotton or micro-fiber towel.
- 6. Some stains may require 2 or more applications.
- 7. If surface is to be sealed, allow 24 hours drying time prior to applying a high quality OMNI sealer (see OMNI Product Recommendation Guide).

SIZES:

12 oz. Jar (other sizes available by special order).

COVERAGE:

Approx. 25 to 75 sq. ft. (2.3m² to 7.0m²) per 12 oz jar depending on the type of surface, porosity, texture, temperature and method of application.
